Open Enrollment



<u>Open Enrollment is from November 4 - December 2</u>. Information about the 2020 benefits and rates will be shared in the billing that goes out around the 10th. Any individual or housing authority needing to make changes to coverages needs to do so during Open Enrollment. Employees making changes should use the attached enrollment/change form. This is an updated form. Housing authorities should save it to their files if they are not currently using this newer form. Housing authorities needing to make employer changes may contact Susan Strange at <u>sstrange@oeccwildlblue.com</u> for the necessary forms. If no changes are needed nothing needs to be submitted.



Adult Immunizations

See the attached flier about preventative immunizations and where to get them at no cost to you. They may also be given by the nurse in the doctor's office at no cost, if you do not make an appointment to see the doctor.

Beneficiary Changes

If an employee needs to change a beneficiary for his or her Life/ AD&D coverage, it should be recorded on the employee/change form. The form needs to be kept in the employee's file at the housing authority. It does not need to be submitted to Mercer or anywhere else.

For <u>all agencies with less than 20</u> <u>employees</u> the Medicare Exception applies. Each participant in the medical plan that reaches the age of 65 must enroll in Medicare Part B in addition to Part A. Medicare will become the primary coverage and the HBP premium will be significantly reduced for this participant. Bonnie Cooper of PBA will contact members when this applies and walk them through the steps.
